ORDER & REASONS

Before the Court is a motion by defendants BP Exploration & Production Inc., BP America Production Company, and BP p.l.c. (collectively, “BP”) for summary judgment.¹ The motion was set for submission on August 25, 2022.² Local Rule 7.5 of the United States District Court for the Eastern District of Louisiana requires that a memorandum in opposition to a motion be filed no later than eight days before the noticed submission date, which deadline in this instance was August 17, 2022. Plaintiff Sherrie McKinley, who is represented by counsel, did not file an opposition. Accordingly, because the motion is unopposed and appears to have merit,³

³ This toxic-tort case arises out of the Deepwater Horizon oil spill that occurred on April 20, 2010. McKinley filed this suit in 2017, alleging that toxic exposures from the oil spill, oil-spill response, or cleanup caused her and her minor child to develop medical conditions, including headaches, breathing problems, abdominal pain and cramps, decreased sense of smell, diarrhea, dizziness, asthma exacerbation, eye burning and irritation, fainting, sinus pain, nasal congestion and discharge, nausea, nose bleeds, shortness of breath, wheezing, vomiting, throat irritation, skin issues including boils, rashes, crusting, irritation, dryness, itching, peeling, scaling, acne oil, blistering, inflammation, lesions, and welts. R. Docs. 1-1 at 5; 1-3 at 5. McKinley’s case, which was originally part of the multidistrict litigation (“MDL”) arising out of the Deepwater Horizon incident and known as a “B3” case, was severed from the MDL and reallocated to this section of court. R. Doc. 6. On November 10, 2021, this Court entered a scheduling order that set August 1, 2022, as McKinley’s expert disclosure deadline. R. Doc. 36 at 3. To date, McKinley has not designated any experts. R. Docs. 42-1 at 1; 42-2 at 2-3. A B3 plaintiff must prove that exposure to oil, a chemical, or other substance legally caused his or her physical condition. Generally, ““when the conclusion regarding medical causation is not one within common knowledge, expert medical testimony is required to prove causation.”” *Cibilic v. BP Expl. & Prod.*, 2017 WL 1064954, at *2 (E.D. La. Mar. 21, 2017) (quoting *Lassiegné v. Taco Bell Corp.*, 202 F. Supp. 2d 512, 524 (E.D. La. 2002)). Expert testimony is required to establish causation in toxic-tort cases where “[s]cientific knowledge of the harmful level of exposure to a chemical, plus knowledge that the plaintiff was exposed to such quantities, are minimal facts necessary to sustain the plaintiffs’ burden” of proof. *Seaman v. Seacor Marine L.L.C.*, 326 F. App’x 721, 723 (5th Cir. 2009) (quoting *Allen v. Pa. Eng’g Corp.*, 102 F.3d 194, 199 (5th Cir. 1996)).

IT IS ORDERED that BP's motion for summary judgment (R. Doc. 42) is GRANTED, and McKinley's claims are DISMISSED WITH PREJUDICE.
